Eligibility Criteria and Instructions for the Shortlisted Candidates.

- At least one of the following criteria must be met:
 - Four year Bachelor degree in any discipline with 60% marks/6.5 CPI (55% marks/6.0 CPI for SC/ST) and at least two years work experience.
 - Masters degree in any discipline (MBA/M.Tech./M.S./M.Sc./ M.A./ M.Com./MCA/ LLM/ M.Pharm./M.Phil., etc.) or 2 year PG Diploma in Management from institutions/universities incorporated by an act of parliament or state legislature in India or other institutions declared to be deemed as University under Section 3 of the UGC Act, 1956, or possess an equivalent qualification recognized by the Ministry of Education, Government of India or AICTE or AIU or reputed foreign university with 60% marks/6.5 CPI (55% marks/ 6.0 CPI for SC/ST).
 - Executive MBA of at least one year duration from IITs/IIMs or institutions /universities incorporated by an act of parliament or state legislature in India or other institutions declared to be deemed as University under Section 3 of the UGC Act, 1956, or possess an equivalent qualification recognized by the Ministry of Education, Government of India or AICTE or AIU or reputed foreign university with 60% marks/6.5 CPI (55% marks/ 6.0 CPI for SC/ST).
 - CA/CS/CFA, and ICWA (CMA) with 60% marks/ 6.5 CPI (55% marks/ 6.0 CPI for SC/ST) in the preceding degree/Bachelors Degree (B.Sc./ B.Com./ BA).
- The candidates are shortlisted for interview based on their performance in the written aptitude test. **(Date: Dec 9, 2025, Reporting Time: 8.30am, Written Test at 9.00am, and Interviews will commence at 2 PM, and Venue is SJMSOM Office)**
- The External (EX) category candidates are required to provide letter of support for Ph.D. from their organization at the time of joining. They are required to identify external Supervisor from their organization (preferably having Ph.D).
- The students admitted under Self-Finance (SF) category have to report on all working days until they submit their thesis as per institute rules.
- The students admitted under College Teacher (CT) category also have to submit letter of support for Ph.D. from their institution/university.
- All students have to fulfill attendance and other academic requirements as per applicable institute rules.
